## **Original Request and Response**

Please find below our response to your request for information in accordance with the Freedom of Information Act.

1. Could you kindly provide me with the latest DPIA that you rely on for, or which covers, such secondary uses processing?

**Trust Response –** The Wirral Care Record DPIA is currently being reviewed by Healthy Wirral. We have been advised that the DPIA will be circulated for review by relevant stakeholders in October 21. Please find the attached original Information Sharing Agreement with an embedded Privacy Impact Assessment in an anonymized format.

2. What is the legal avenue under the common law of confidentiality for the disclosure of, and subsequent access to, linkage, de-identification, data analysis, and any onward disclosure of information *for secondary uses processing* by your organisation? (That is, how is a breach of confidence avoided?)

**Trust Response** – The data processed in the Wirral Care Record is processed for provision of health/social care purposes. Staff accessing information processed within the Wirral Care Record have a legitimate relationship with the patients/clients, in providing their care and treatment. The information held in the Wirral Care Record is not currently processed beyond these purposes.
